1. Please include a copy of your most recent tax return(s) with this application. The application will not be considered complete if it is not received.
2. Please ensure that the application form is completed in its entirety, in annual amounts. If you feel that a certain figure needs further explanation, please include this on a separate sheet of paper.
3. For farms or business proprietorships:
  - \*prepare net income (loss) on a full accrual basis. If a cash basis has been used, please request your accountant or other individual with financial expertise to convert to the accrual basis.
  - \*if the farm or business is operated through a partnership, only the family's share of the partnership income (loss) should be included.
  - \*only the personal portion of your family expenses should be included on the financial information page. Expenses already claimed by a farm or business may not also be claimed by the wage earner.
  - \*please indicate whether owner wages taken from the business are being intentionally inflated or deflated for tax planning purposes.
4. Tuition Bursary Applications will be received at any time. Applications received by May 15 for the following school year will receive first priority for fund disbursement.
5. Please be aware that participation in the Voucher Incentive Program (VIP) program is mandatory for families receiving a bursary.
6. Once support levels for the upcoming school year are determined, families may be asked to sign additional documentation which will include repayment terms for any loans granted as a result of this application.

**Applicant Declaration:** I hereby declare that all information shared on this Tuition Bursary Application are correct and accurate to the best of my knowledge. I acknowledge that submission of an application will not guarantee receipt of a bursary, and that I may be required to supply additional information or meet for a personal interview with administration.
